## CMHC History and Programs

CMHC, Inc. was founded in 1978 by a group of doctors recognizing that there is a severe deficit of mental health services in most rural areas. They also realized that rural families require a specialized kind of service that integrates their culture, values, and special needs into the services.

The comprehensive community mental health center is certified for all insurances and managed care companies operating in the region, Medicaid and Medicare, Tri-Care for military personnel, and has a patient balance payment system.



Our facilities accept patients between 8AM to 8PM Monday through Friday and from 8-5 on Saturday. We are on call 24 hours daily for emergent care.

Our physicians and nurses are available for medication management and medical assessment each week.

From the south suburbs of Kansas City to the north suburbs of Joplin our centers are within easy driving access of patients wishing to avoid having to go into the city for services. We are affiliated with the Bates County Memorial Hospital and Primary Care Clinics and are a Department of Mental Health Certified CSTAR and Purchase of Service Program and a Federal Probation and Parole, and DFS Children's Treatment Services Contractor. CMHC, Inc.'s Clinical Director is Board Certified in Addictions and we run a two year Addictions Training Residency.

### Medical Services

Our medical staff perform assessment (histories and physicals), medication management, and brief medical interventions with referrals for specialized and specialty medical services. Weekly appointments are available, and some will choose us as their healthcare home because their psychological services are their paramount concern.

### Substance Abuse Services

Our substance abuse program is certified by the Missouri Department of Mental Health Division of Alcoholism and Drug Abuse and accepts Medicaid, Medicare, Insurance, and Managed Care patients. We offer services to a limited number of cash patients based on internal grants and ability to pay portions



of their bill.

Our menu of services includes Day Treatment, outpatient individual and family substance abuse counseling, group counseling, assessment and treatment of co-occurring disorders, medical assessment and medication management when needed, and psycho educational and recreational services. Our van fleet may be able to pick you up if you have no transportation.

We operate weekend, group, and individualized traffic offender programs which are certified by the state (OMU, and SATOP) for those needing to complete programs for license reinstatement.

Our offender treatment programs satisfy the requirements at the state and federal level for those needing required treatment as a part of probation or parole.
